Volunteer-run chapters - providing online and off-line encouragement and an ongoing creative community - expanded to 643 in over 60 countries. Revision and publishing resources were expanded; participants wrote in their local libraries and bookstores as part of the Come Write In outreach initiative; and advice emails from six well-known authors were sent to participants.

4b (Code:) (Expenses \$ 260,723 including grants of \$) (Revenue \$ 21,503) The Young Writers program: The Young Writers program participation base for NaNoWriMo 2016 was 71,229 kids, teens, and educators participating in over 2,500 K-12 classrooms worldwide. Nearly 25,000 students "won" by reaching their word-count goals. The YWP provides young writers and educators with grade-appropriate resources, including workbooks and lesson plans aligned with Common Core standards.
